The Council provides service through six activities: Education, Counseling, Navigation, Screening & Referral, Therapy & Treatment, and Recovery Support.

- Our education services include community workshops, professional education events, evidence-based curricula programs, and education for mental health and healthcare professionals. Education services are offered in schools, community centers, probation offices, and other places for people who may be interested in or struggling with substance use issues. Our long-term objective for our education activities is to help prevent future generations from experiencing the devastation this disease causes.

- Counseling services support clients affected by another's substance use and those experiencing harm from their own use. Counseling introduces clients to conversations about their struggles and focuses on building coping skills for environmental and social challenges related to substance use, without addressing deeper psychological issues addressed in therapy.

- Navigation services connect clients to various community resources that may help reduce or eliminate stressors, known as social determinants of health, which can lead to substance use.

- Screening & referral use standard questions to assess substance use level and motivation for change. Based on the results and ability to pay, referrals connect individuals to the right treatment providers.

- Outpatient therapy and treatment services explore how a client's family of origin and current family dynamics influence their problematic behaviors. Services provided include structured outpatient therapy to gain insight. Treatment is designed to offer an intensive, structured therapeutic opportunity with minimal disruption to daily life, while gaining insight, skills, and support to create healthier family systems. The program includes group therapy, educational sessions, skill-building activities, family therapy, multi-family education, support groups, and individual therapy.

- Recovery support services are non-clinical support offered to two groups of participants: 1) those who have achieved some level of sobriety and 2) participants taking initial steps to seek treatment and begin the recovery process. We provide face-to-face, phone, virtual, and Internet coaching to help participants start or stay in recovery, offer emotional support in addressing personal life issues, aid in understanding the recovery process, and connect them to the recovery community. We also provide indirect coaching that improves participants' life circumstances and removes obstacles to recovery.

Recovery support services, such as Navigation, help participants address social determinants of health needs, including affordable housing, food insecurity, transportation assistance, childcare, and health and wellness activities. Recovery support also includes providing educational services, such as offering classes on nutrition, parenting, resume building, completing job applications, conducting a job search, budgeting, preparing for the GED exam, and relapse prevention.

We served 38,520 individuals in FY25, including 20,558 under 18 and 17,962 adults.
